In addition the portfolio has to score an average MSCI ESG Rating of «A».

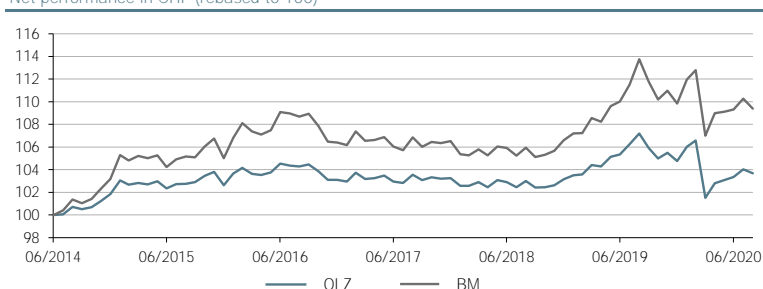
