In addition the portfolio has to score a minimum average MSCI ESG Rating of «A».

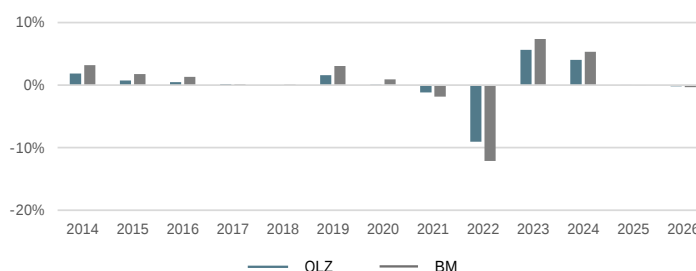
