What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

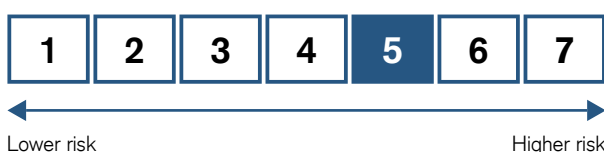
Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: This Equity Sub-fund is actively managed with reference to the MSCI CHINA Index benchmark, aiming to achieve the highest possible return in the issue currency of the respective Class, while taking due account of the principle of risk diversification, the security of the capital invested and the liquidity of the assets. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. The Sub-fund invests at least two-thirds of its assets in equities and equity-type securities of companies domiciled in China and Hong Kong and/or Stocks included in the MSCI CHINA Index. The Investment Manager has full discretion over the composition of the Sub-fund's portfolio even though the securities included in the Benchmark are generally representative of the Sub-fund's portfolio. Different versions of the benchmark, in particular regarding the currency, may be used when presenting the performance of the Sub-fund to investors to take account of, inter alia, hedging activity at the Sub-fund level, if the Investment Manager considers such versions to better reflect the actual performance of the Sub-fund's portfolio. There are no restrictions on the extent to which the Sub-fund's portfolio and performance may deviate from the ones of the Benchmark. Such deviation may be material. Moreover, the Sub-fund may invest up to 49% of its net assets in units or shares of collective investment schemes. Investments in cash or deposits, money market instruments and money market funds cannot exceed 30% of the Sub-fund's net assets. The Sub-fund may also use financial derivative instruments such as futures, swaps (with the exception of total return swaps) and options for hedging purposes and/or efficient portfolio management. More than 50% of the Sub-fund's assets will be invested on an ongoing basis in equity participations within the meaning of German Investment Tax Act ("GInvTA"). As part of the selection of investments for the Sub-fund, the applicable investment regulations for financial investments of Swiss pension funds of the Swiss Federal Act on Occupational Retirement, Survivors' and Disability Pension Plans (BVG) and the Swiss Ordinance on Occupational Retirement, Survivors' and Disability Pension Plans (BVV 2) are taken into account. Among others, they foresee strict limitations or exclusions with respect to exposure within the asset classes and set forth rules concerning aspects such as hedging, short selling etc. The Sub-fund uses derivatives to reduce the impact of changes in currency exchange rates on the performance for this Share Class. The investor can buy or sell shares of the Sub-fund on a daily basis (Luxembourg bank business day). This share class does not make regular distributions. The Sub-fund shall bear the costs of standard brokerage charges and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear an average investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 7 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 5 out of 7, which is a medium-high risk class and poor market conditions will likely impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. Investors shall note that the Product may be exposed to further risks such as operational, counterparty, political, sustainability and legal risks that are not included in the Summary Risk Indicator. This Product does not include any protection from future market performance so you could lose some or all of your investment.

Recommended holding period: 7 years

The recommended holding period is calculated based on the Summary Risk Indicator presented above. The investor can sell their investment on a daily (on business days) basis. Redemption fees will be charged at the level of the Product.
