Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, and potential gains and losses of this product and to help you compare it with other products.

What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: This Equity Sub-fund is actively managed with reference to the MSCI Emerging Markets ex China (the "Benchmark"), respecting ESG (Environment, Social and Governance) criteria and aiming for capital appreciation in CHF. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. At least two-thirds of the Sub-fund's assets are invested in equities and equity-type securities of companies domiciled in emerging countries (including India) or in companies that conduct most of their business in emerging markets. The Investment Manager will use its discretion to significantly deviate from the weighting of certain components of the benchmark and to significantly invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities. It is thus expected that the performance of the Sub-fund will significantly deviate from the benchmark. In order to reach its objective, the Sub-fund can invest in structured products and use derivatives. As part of the selection of investments for the Sub-fund, the applicable investment regulations for financial investments of Swiss pension funds of the Swiss Federal Act on Occupational Retirement, Survivors' and Disability Pension Plans (BVG) and the Swiss Ordinance on Occupational Retirement, Survivors' and Disability Pension Plans (BVV 2) are taken into account. Among others, they foresee strict limitations or exclusions with respect to exposure within the asset classes and set forth rules concerning aspects such as hedging, short selling etc. The investor can buy or sell shares of the Sub-fund on a daily basis (Luxembourg bank business day). This share class does not make regular distributions. The Sub-fund shall bear the costs of standard brokerage charges and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear an average investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 7 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 4 out of 7, which is a medium risk class and poor market conditions could impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. Investors shall note that the Product may be exposed to further risks such as operational, counterparty, political, sustainability and legal risks that are not included in the Summary Risk Indicator. This Product does not include any protection from future market performance so you could lose some or all of your investment.

Recommended holding period: 7 years
